Over the past year, so many family and friendship bonds have been broken.

Families have been separated, friends have been detached, and all of us have been divided in some way from our usual routines. For the families, seniors, and teens we serve, this has been a particularly difficult time. Unable to visit seniors in-person and with our children learning remotely we saw the need to reconnect and bring a semblance of normalcy to their lives.

You will be pleased to know that our amazing staff was very creative in reconnecting children with their teachers, seniors with their friends, and our teens and youth with the joy of being a kid.

For example, last year as part of COVID protocols, parents were restricted from entering our buildings. They had to leave their children at the front door to be escorted by staff to their classrooms. To improve the connection between parents and teachers, we utilized the TSG app to facilitate regular communications. Today, our parents are reconnecting by meeting our teachers and bringing their children to the classroom door.

Our seniors, often isolated at home, learned how to use Zoom from our Outreach staff to virtually reconnect with their Take Charge friends. Often

connecting with others for the first time in months!

Our School Age and Hope Junior participants were able to reconnect with their city and their friends this summer by taking field trips to parks, the pool, and Lincoln Park Zoo. Outdoor distanced activities where our youth experienced summer fun.

Thank you for your committed partnership in assisting our staff in making all this possible. Indeed, together, we have made a positive difference in the lives of the people we serve. I hope you enjoy the stories in this Annual Report of our shared work and mission of building vibrant communities in Chicago.

# EMPOWERING FAMILIES

*"I really like Marillac. It gives you a sense of family. It gives you a sense of support. I've met a lot of fantastic people I never thought I would have met and done a lot of things I never thought I would have done. I was blessed to be able to put my daughter in a good school."*

Like any caring parent, **China** was nervous about placing her young daughter **London** in an early-learning center she was unfamiliar with. How would she get along with other kids? How would her teachers treat her? Word of mouth convinced her to give Marillac a try, and two years later she has no regrets.

When one of our family support specialists suggested she join the Parent Policy Committee, she agreed. It was an opportunity for her to get an inside look at the curriculum, activities, food options, and staff hiring that affected her daughter. "I'm a good parent, but I also want to see – what's my child doing on a day to day basis? What is she learning? I want to see stuff like that. I want to know. It's important to me."

The parent committee at Marillac works to engage families. They are not only tasked with reviewing budgets and approving reports, but they actively plan events for parents and children as well. Additionally, they receive training in managing and maintaining grants that fund their children's education and have opportunities to look at how other schools and early learning centers across the city are performing.

China loves to be involved and is grateful for the leadership

opportunities she has had. This past year, China not only served as Chairperson of the parent committee at Marillac, she also served as Treasurer for the city-wide committee where she could also influence matters that affected young children across Chicago. Her involvement keeps her busy, but she does not mind. "I've got a lot of meetings. I have at least 3 meetings here a month, but I also meet regularly with staff. I'm in every meeting, and that's good. I appreciate that they value my opinions."

London transitioned to e-learning when the pandemic forced our centers to close, but it wasn't the same. "She missed school. She missed her teachers. She missed her classmates. That's all she would say, 'I'm going back to school mom. I'm gonna see my teachers. I want to see my friends,'" recalls China.

With the centers reopened, the opportunity for reconnection is one that both China and London are grateful for. "It feels good to see people face to face. When we brought London back, she was so happy. It feels good to see your child be happy. You could tell something was missing. My heart lights up when she sees her friends because you love to see your kids smile and be happy."

# STRENGTHENING COMMUNITIES

*"The Wellness Closet was originally just basic clothing items, but we realized we could be doing more than that."*

Responding to feedback to create the best experience possible is a top priority for the Community Outreach teams at both Marillac St. Vincent sites.

At St. Vincent de Paul Center, staff launched the new **Wellness Closet**, an initiative created to serve the everyday needs of clients. "The Wellness Closet was originally just basic clothing items, but we realized we could be doing more than that," explained **Community Outreach Manager, Tramaine Martin**.

The closet, like MSV's food pantries, was designed with the client-choice model in mind. It is set up to look like the aisle of a store and is stocked with everything from basic clothing items like socks and undergarments to hygiene products and more. The initiative aims to provide goods that promote client wellness and works to fill the needs of each person holistically.

Clients can make appointments via phone or email during the week and the Community Outreach team works to make the experience as comfortable and empowering for customers as possible. "We put on relaxing music and sometimes even light a candle to make sure that customers are relaxed while they shop the closet," said Martin.

**Holly Yacoumakis, Food Pantry Supervisor** at the Foglia Center on the west side is adapting as well. "We noticed a need from our clients for hygiene items like soap, toothpaste, tampons, and much more. We used to give folks travel-sized items because that was all we could do. We thought, we could do more and open once a month to do full-sized items. We used a Jiganti Fund grant to get started. So far, clients love it. They ask about it on food distribution days. We're now leveraging pre-existing relationships with partners to continue to supply our Hygiene Closet."

The entire Outreach team is dedicated to making the closets completely client-centric and several changes have already been instituted based on client feedback. At St. Vincent, changes like music and candles have been added to the experience based off feedback from clients. Both closets will continue to evolve as they grow to meet the needs of clients.

"So far, the client feedback has been very positive. We hope to continue this trend and I'm excited to watch the Wellness Closet evolve to meet the needs of clients. This initiative was created to be entirely client focused and we hope to meet and exceed our goals," explained Martin.

# TRAUMA-INFORMED CARE

The Trauma-Informed Care initiative is well underway at MSV. Our goal of becoming a fully trauma-informed agency is not a small one, but it could not possibly be more timely. In an age where global, national, and community traumas abound our Vincentian mission calls us to be of service *"in the Vincentian spirit"* – that is to say, recognizing the image of Christ in every person we encounter. This is what we strive to do and the trauma-informed approach provides critical information and skills development that make us more successful in living our mission.

At its core, **Trauma-Informed Care is a universal precautions approach to deliver service that recognizes and responds to the reality that trauma histories are prevalent in our society.** Led by **Sr. Salvatrice Murphy**, all MSV staff participate in a "Trauma 101" workshop to gain an understanding of how trauma impacts behavior and what that might look like in the workplace. Additionally, MSV has adopted the **Crisis Prevention Institute (CPI)** model of trauma-informed verbal de-escalation and crisis intervention. The leadership team has undergone a series of trainings to become CPI certified and our hope is to expand this certification to all agency staff.

Professional development can be the most impactful step in becoming a trauma-informed agency, but it is not the only step. Creating an environment that reduces the chances of re-traumatizing people requires us to assess our facilities for things like lighting, signage, and comfort. We are reviewing our policies and procedures through a trauma-informed lens looking for clarity, equity, and collaboration. With each insight and adjustment we are a step closer to being a fully trauma-informed agency.

# BUILDING BRIGHTER FUTURES

**Laquesha** was raised in Chicago and graduated from Marshall High School. Inspired by police shows like Criminal Minds and Law and Order she dreamed of having a career helping others either as a police officer or probation officer. While attending Harold Washington Chicago Community College studying to get a criminal justice degree and working at Primark, her life was about to change.

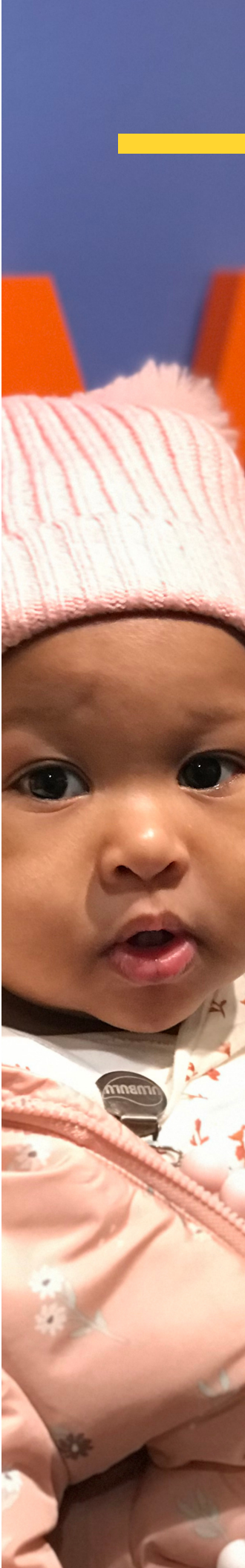
Pregnant at a young age and not sure where to turn, Laquesha reconnected with Marillac St. Vincent Family Services. Her positive memories of attending MSV's Early Childhood Education program, Hope Junior and her many happy days of field trips, friendships and her first job at MSV gave her the confidence to seek out **Melanie McCullough** and **Project Hope**.

Project Hope provides: prenatal and parenting groups that focus on the relationship between mother and baby, regular home visits before and after the birth of the child, Doula birthing services that support young mothers during labor and delivery and referrals to schools, housing, health agencies, job training and recreational activities.

Melanie McCullough recalls the day that Laquesha came into her office. "Like most young moms-to-be she was scared and unprepared for the challenge of delivery and motherhood."

Struggling through pregnancy, COVID-19 and virtual meetings, Laquesha met weekly with MSV staff and other moms to learn the ABC's of having a baby. "I learned about preventing SIDS, infant oral hygiene and so many other things. But, I was confident that armed with that information that Project Hope provided, I was ready to be a great mom," recalled Laquesha. "I also learned that my mom was awesome and I told her that I appreciate all you have done for me." Her daughter **Kourtney** was born in early 2021.

According to Laquesha, "Without Project Hope, I would not have the confidence to be a great mom, Kourtney would not be in Early Childhood Education at MSV, I would not be working and back to school to earn my degree. "When asked about her future, Laquesha's plan is to save her money to buy a bigger place so that Kourtney can have the space to run and play. Laquesha ended by saying, "No matter how long it takes, I am going to achieve my dreams."

# GRATEFUL FOR OUR VOLUNTEERS

At the start of FY21, MSV, along with the rest of the world, was four months into living with the new routines of pandemic life and CDC guidelines. For many of MSV's volunteers, that meant that for four months a key point of connection with our children, families and clients had been put on hold. While many amazing new volunteers responded to our early call for help providing food assistance, our ongoing volunteers in other programs wondered when they would be able to share their time and gifts with MSV again.

Thankfully, in July the **Nearly New** volunteers were able to return and help re-open the store, and several of our senior/veteran volunteers chose to resume service in our pantries as infection rates slowed and they felt safe to return. In lieu of after-school tutoring and activities on-site, **DePaul's** student athletes created mini-fitness-and-fun videos to share with students and families, while continuing their ministry of making and providing fleece blankets to our Outreach and Family Support programs. DePaul's Community Service Associates bravely co-created a new, virtual-volunteer program with our team of e-learning teachers in Early Childhood. Diehard annual holiday volunteers showed up to drop off donations, help sort toys, and pre-pack gift bags for our adapted drive-up Christmas Store. And throughout the year, groups and individuals who would have normally given their time on-site—from partners such as **Trinity High School, St. Clement Parish, Christ the King Jesuit, Nazareth Academy, and St. Ignatius**—rallied to collect donations and raise awareness of our ongoing work. As we look ahead, we anticipate reconnecting with all of our volunteers.
